Teaching in the Simon School of Business 1971 - Present

Since joining the Simon School in 1971, I have taught managerial economics to full-time and part-time MBAs, US executive students, students in our international executive programs and students in our one-year master's in medical management. I have won eight teaching awards for that course.

I developed a course on how executives impact company outcomes. It is a required core course that examines how executives build and manage organizations in ways that improve execution. I have taught versions this course for three decades to full-time and part-time MBAs, executive students and starting in 2018 undergraduates.

I was trained as a macro economist and applied price theorist in an economics department. The intellectual foundations of the Rochester graduate business curriculum when I arrived and for most of my tenure at Simon was such that applied price theory was an integral part of many courses in the school's MBA programs. As a result, I had the opportunity to teach other functional courses on strategy, marketing, finance, and construction of business plans.

I also taught statistics to executive students, a course on financial institutions and macroeconomics winning teaching awards for the first two. Finally, I taught management communication courses to all full-time MBAs.

In the spring semester of 2022, I created and taught an undergraduate course on research methods. I offered that course again in the spring semester of 2023 growing the enrollment from 4 students in 2022 to 11 in 2023.

Program Development

Simon School Coach Program 1998 - 2015

I founded the Simon School Coach Program and served as faculty adviser through September of 2014. The Simon School organizes all first-year MBA students into teams for the core courses they complete during their first year of study. The coach program involves recruiting second-year, full-time MBA students to coach first-year teams and to monitor the performance of those coaches. The program began in 1998 when Stacey Kole and I received a grant from General Electric to develop it. Responsibilities involved choosing second year students to serve as leaders who manage the program. The leaders had primary responsibility for selecting and monitoring the second-year students who serve as team coaches. I supervised the coach leaders and jointly participated in monitoring some coaches. The program was discontinued because it is incompatible with a recently implemented new academic calendar.

Dutch and Swiss Executive Programs

I designed the curriculum for an executive MBA jointly offered in Holland by the William E. Simon Graduate School of Business Administration and Erasmus University until 1995. The equivalent of that program was jointly offered by the Simon School and Nyenrode University in Holland until 2004 and is now offered jointly by the Simon School and the Institute for Finance of the University of Bern in Switzerland. The Simon School awards or awarded participants in each program a University of Rochester MBA. I initiated the negotiations with Erasmus University in 1985, managed the recruiting of the initial classes and supervised general program operation during its first four years.
